Leadership Definition

▶ “Leadership is an influence relationship among leaders and followers who intend real change that reflect their mutual purposes.”

▶ Joseph C. Rost, *Leadership for the Twenty-First Century*, 1993

Definition of Servant Leadership

- ▶ “The servant-leader is servant first. It begins with the natural feeling that one wants to serve. Then conscious choice brings one to aspire to lead. The best test is : do those served grow as persons; do they, while being served, become healthier, wiser, freer. More autonomous, more likely themselves to become servants?”

What Jesus says about leadership

- ▶ “You call me Teacher and Lord, and you are right. If I then, your Lord and Teacher, have washed your feet, you also ought to wash one another’s feet. For I have given you an example, that you also should do just as I have done to you. Truly, truly, I say to you, a servant is not greater than his master, nor is a messenger greater than the one who sent him. If you know these things, blessed are you if you do them. John 13: 13-17, ESV


Ten Characteristics of the Servant-Leader

- ▶ **Listening**, or talking?
- ▶ **Empathy**, or is everything all about them?
- ▶ **Healing**, or are they harming or hurting others?
- ▶ **Awareness**, or Insensitive to cues or others?
- ▶ **Persuasion**, or Dictation?
- ▶ **Conceptualization**, can they paint compelling word-pictures?
- ▶ **Foresight**, do they see where the story goes, or how it ends?
- ▶ **Stewardship**, or spending resources on foolish frivolity?
- ▶ **Commitment to growth of their people**, are the people thriving?
- ▶ **Building community**, or destroying it?
